INTRODUCTION

This book is a small part of a big revolution. The revolution is the introduction of the Unix operating system into the everyday computing environment of regular computer users. Never before have so many people had access to a common, powerful, and stable platform that is open to being reshaped through the collaborative efforts of all who wish to contribute.

Mac OS X is now the world's most common version of Unix on the desktop, and you are among the first Mac users to dig into the tools that await you below the surface. If you're not a Mac user and are thinking about Mac OS X, jump right in—you'll be able to follow the book just fine. If you are an experienced Unix user wondering about Mac OS X, take it from us, it really is Unix—not almost, not sort of, but actual, real Unix with the Lovely Mac Interface.

This book is intended to help you, the adventurous Macintosh user, explore the power and variety of the Unix substructure upon which Mac OS X elegantly builds.

Unix is an operating system, and obviously you have used other operating systems in the past—at the very least, you have used the Macintosh operating system, and perhaps Windows, or even DOS. Unix is different. The other operating systems have a sharp distinction between the operating system itself and the applications you use with it. In Unix, the distinction is much less clear.

In learning Unix, you will use a collection of separate applications to do things like copy files, create new folders, view information like file size and date modified, and perform all the tasks that in other operating systems are part of the one big application that is the “operating system.”

It has been said that if Unix were an airplane, it would have been built by all the frequent fliers who over the years showed up at the airport with new and/or improved pieces for the airplane. Each time someone had a better, faster (and sometimes even easier) way of doing something, all the other frequent fliers—along with the engineers

working for the airplane manufacturer—would crowd around and argue over the benefits of the new tool.

In many cases a new tool (or toy) became a standard part of the airplane. Unix was invented in 1969, but it wasn't until the early 1980s that engineers at the University of California at Berkeley added the code for communicating on the Internet directly into the core (or *kernel*) of Unix. The tools for viewing files and monitoring the operating system have evolved constantly over the years.

New tools are added frequently. Each of them is a separate piece of software, with its own collection of features, options, and tricks for using it; and all of them (or almost all) are designed to be combined with each other in the way that words are combined to make a sentence.

All this means that Unix has evolved organically over the past 30-plus years, and continues to evolve, very much as a language evolves. In this book, we teach you how to think and act in Unix step-by-step, providing you with both a sequential learning process and a reference you can return to in the days to come as you become more and more adept.

Learning Unix is like learning a language—it all comes together to make some kind of sense, but there are idiosyncrasies and bits of historical stuff that pop up. It is not smoothly monolithic, but rather it is gloriously rich and complex. Instead of words, though, Unix has tools.

In Unix we call these tools *commands*, and you will start thinking about “which command to use” just as if you were some kind of authority figure, or wizard, which indeed you are on your way to becoming. Unix experts sometimes speak of “invoking” commands, as if they were magic spells. Perhaps that is not far from the truth.

You will see more similarity between Unix and language as you recognize that Unix commands achieve much of their value from the ways in which they can be combined with each other and even modified as the need arises.

This book teaches you how to perform the tasks necessary to accomplish traditional actions with your computer. Performing a task in Unix is frequently a matter of using two or more commands in a particular sequence. For example, you will use one command to create a new folder, another command to move within that folder, then another command to create a file, and still another command to set the permissions on the file so that you can control who is allowed to use it.

Unix is a world where a string of commands displays a specificity so unique, it results in an exact execution of your intention. Although such an incantation may seem obscure to a novice, the experienced user will see only directness, simplicity, and precision. We'll help you move from the former to the latter.

Who Is This Book For?

This book was written primarily with three audiences in mind:

- ◆ Experienced Mac users who want to learn Unix.
You are the folks who we expect will actually read and use this book.
We don't expect you to know anything at all about Unix before you read the book (but you will know a great deal about it when you are done). We'll teach you all the basic Unix skills and provide you with a solid reference book to turn to in the future.
We assume that you are adventurous, creative, and curious (hey, you *are* a Mac user, after all).
We also assume that you have experience with the Macintosh and have become comfortable with the new Aqua interface introduced in Mac OS X. If you are new to Mac OS X, we suggest that you also read Peachpit Press's *Mac OS X: Visual QuickStart Guide*, by Maria Langer. (www.peachpit.com/books).
- ◆ Beginning Unix users who are excited about using Unix on the Macintosh.
If you are a new Unix user who has learned a little Unix already, you'll find this book a thorough reference for all the basic Unix skills. It will probably teach you a few things you haven't learned yet.

- ◆ Expert Unix users. You have installed and configured Unix systems in your sleep. You know the differences between the System V and BSD versions of the `ps` command. You have a favorite in the `vi` versus `emacs` debate. Your Unix-novice Mac-using friends keep calling you for help with `cd` and `ls`.

If you already know your way around Unix, the simple fact is that you already know your way around 90 percent of Unix on Mac OS X. As we describe in Chapter 1, Mac OS X includes a complete Unix system, Darwin, that is based mostly on FreeBSD 4.4 and that you can use just like any other Unix system. Yes, there are a few differences (marked in this book with the Darwin mascot, Hexley),



but mostly it's the same as other Unix systems you have used.

We hope you'll buy this book by the case-load and give copies to friends who are new to Unix, so they'll stop pestering you with basic questions.

What's in This Book?

Simply put, an introduction to Unix.

We give you instructions on how to perform dozens of tasks using standard Unix tools. At least 90 percent of what you will learn from this book applies to other Unix systems, such as GNU/Linux, FreeBSD, and Sun Microsystems' Solaris.

The book consists of 15 chapters, containing more than 400 specific tasks that cover everything from the basics of using the Unix command line to Unix system administration and the installation and configuration of Unix software.

An introduction to Unix

We start off by introducing you to Unix itself in Chapter 1, "What is Unix, and Why Is It Good," in which we explain what Unix is, and describe the relationships between Mac OS X, Unix, Darwin, and Aqua.

The basics of the Unix command-line interface

In Chapter 2, "Using the Command Line," we teach you the basics of the command-line interface. This is the primary interface to Unix, and almost every task in the book is performed using only the keyboard; the mouse is hardly used at all.

In Chapter 3, "Getting Help and Using the Unix Manual," we teach you how to find and read the Unix documentation and how to get more help.

In Chapter 4, "Useful Unix Utilities," we give you instructions for the most common and useful Unix utility programs, including file compression and searching for text, as well as for a set of utilities that are unique to Mac OS X.

Chapter 5, "Using Files and Directories," provides more detailed instruction in the fundamental Unix skills of moving around your disk, and of viewing, creating, copying, and renaming directories and files (*directory* is what Unix calls a folder).

Beyond the basics: editing, permissions, and programming

Chapter 6, "Editing and Printing Files," is devoted to the use of Unix tools to perform these functions. We teach you how to use the standard Unix editor (called *vi*), which is a keyboard-only editor (no mouse!) that is available on virtually every Unix system in the world.

In Chapter 7, "Configuring Your Unix Environment," we teach you how to create shortcuts (*aliases* in Mac-speak) for commands and change settings (called *environment variables*) that many Unix programs use.

Chapter 8, "Working with Permissions and Ownership," teaches you how to work with one of Unix's more complex facets. We show you how to view the permission settings on files, how to change them, and what each of the dozens of possible settings means.

Chapter 9, "Creating and Using Scripts," is an introduction to simple Unix programming. We teach you about the fundamental building blocks of all programming and how to use each of them: variables, arguments, expressions, control structures, user input, and functions.

Using the Internet

Chapter 10, “Connecting Over the Internet” covers several different methods for interacting with other machines over the Internet. These include logging in to other machines using a command-line interface, and transferring files between machines.

Intermediate skills—system administration and security

Chapter 11, “Introduction to System Administration,” is a hefty introduction to managing Unix systems. We show you how to use the all-powerful “root” account, add and remove users, back up essential files, run commands automatically, monitor system use, and perform some basic repairs using Unix tools.

In Chapter 12, “Security,” you’ll learn about the security of your machine and how to improve it, and we pay particular attention to measures that can protect your machine from attacks that come across the Internet.

Installing and configuring software

The last three chapters take you deeper into Unix by teaching you about the installation and configuration of Unix software.

Chapter 13, “Installing Software from Source Code,” gives instructions on how to download and install the vast collection of Unix software that is available in *source-code* form. This is software for which the underlying programming code is available for download, and which you then turn into usable software through a process called *compiling*.

Chapter 14, “Installing and Configuring Servers,” continues the theme of software installation by concentrating on *server* software. This is software that runs on your Mac to provide services to other machines over a network (typically over the Internet). Chapter 14 teaches you about servers that enable your Mac to be a Web server, an email server, a file-sharing server for other Macs *and* for Windows machines, and more.

Chapter 15, “More Open-Source Software” (on the Web at www.peachpit.com/umox) introduces you to eight more packages, selected for the diverse range of features they offer.

Glossary and where to learn more

Finally, we provide a glossary to help you quickly find the meanings of many terms that are found in the book (we also explain each one as it appears, of course!), and an appendix listing places to get even more help, including a summary of most of the Web sites we refer to throughout the course of the book.

How to Use This Book

Unix for Mac OS X: Visual QuickPro Guide is designed so that each chapter builds upon the skills and understanding taught in the preceding chapters. So before we teach you how to edit files using Unix tools (in Chapter 6, “Editing and Printing Files”), for example, we show you how to work with files in general (in Chapter 5, “Using Files and Directories”).

- ◆ If you are completely new to Unix, we recommend that you work your way through the book chapter by chapter, at least through Chapter 12, “Security.”
- ◆ If you already know a bit of Unix, take a few minutes to skim through the first six chapters, and if you already know the skills we cover, see if you want to work through them in detail. Then decide if you want to work through the book chapter-by-chapter or use it as a reference as you poke around Mac OS X on your own. You’ll find instructions on getting to the command line in Chapter 2, “Using the Command Line.”
- ◆ If you are a hotshot Unix expert, gift wrap the book and give it to your favorite Mac user.

Most of this book consists of specific tasks laid out in a step-by-step fashion, with accompanying illustrations and examples of your input and the computer’s output. The chapters and tasks are intended to be used as a tutorial, to teach you how to perform and understand the particular tasks and larger concepts. The book is also meant to be a reference work you will come back to as you continue to learn Unix, and you find and create more uses for Unix.

Graphic conventions

We use the following graphic conventions throughout this book:

Keyboard symbols

Where we want to indicate that you must press a particular key, we use special symbols such as \mathcal{R} and \mathcal{C} .

Whenever we show you a command or line of text to type into the computer, we assume that you will press \mathcal{R} at the end of the line unless we tell you not to. To avoid visual clutter and repetition, we do not put the \mathcal{R} symbol at the end of every line.

bold

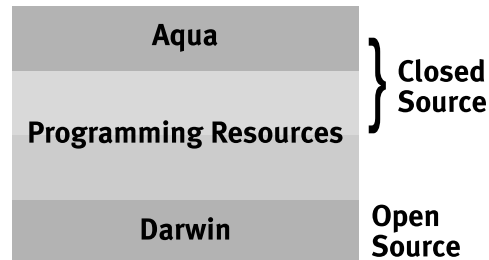


Figure 0.1 Diagram showing the large-scale software layers of Mac OS X with the Aqua user interface on top and the Darwin Unix layer at the foundation.

Used for figure and table references. For example, “**Figure 0.1** shows the ‘layers’ of Mac OS X, with the Aqua user interface on ‘top’ and the Darwin Unix layer at the foundation. **Table 0.1** is an example of a table.”

About “vanilla”

Throughout this book we use the made-up user name “vanilla” (and sometimes another one called “puffball”).

Whenever you see *vanilla*, you should substitute your own short user name. Your home directory has the same name as your short user name.

code text

Used for Unix command-line text, including Unix commands and filenames. Basically, if you see something in code text, that means it is literally what would be typed into or would come out of the computer. If a line of text is too long for this book’s margins, a gray arrow indicates that the code should be typed on a single line.

code highlight

Used in figures to distinguish text you type in from text that comes from the computer. **Figure 0.2** is an example of how code text and **code highlight** appear in a figure.

code italics

These indicate text that you type into the computer but where you must substitute the appropriate value for the italicized text. For example, if you see

```
ls -l filename
```

then you would type the `ls -l` part literally, and then the name of a file instead of *filename*.

body-text italics

Used for emphasis and also to introduce words and phrases that are likely to be unfamiliar to Unix novices. For example, “The Unix concept of the *working directory* is similar to the GUI concept of the active window.”

case-sensitivity

In Unix, filenames and command names are case-sensitive. The Macintosh preserves the case when it stores filenames, though they’re case-insensitive. This means that there are some situations in which `COMMAND` and `command` are the same, but because those are exceptions and because case-sensitivity is the Unix standard, we assume that all commands and filenames are case-sensitive unless otherwise noted.

Darwin-specific features

The image in **Figure 0.3** is Hexley, the mascot/logo for Darwin, which is the name of the Unix part of Mac OS X (see www.hexley.com). We use Hexley to indicate features of the Mac OS X's Unix environment that differ from most other Unix versions. Most of the Unix features of Mac OS X do *not* differ from other Unix systems.

Mac OS X-specific feature

The icon at right is used to indicate a Unix feature that occurs only in Mac OS X. For example, there are some Unix tools included with Mac OS X for dealing with files created by older Mac applications, but these tools are not standard parts of any other version of Unix.



Figure 0.3 This is Hexley, the mascot/logo for Darwin. Darwin is the name of the version of Unix used as the foundation of Mac OS X.

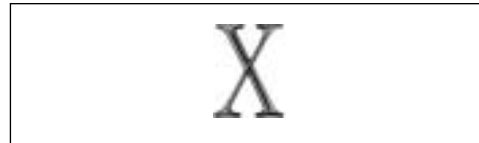


Figure 0.4 This icon is used to indicate a Unix feature that is available in Mac OS X and is not a standard part of other versions of Unix.

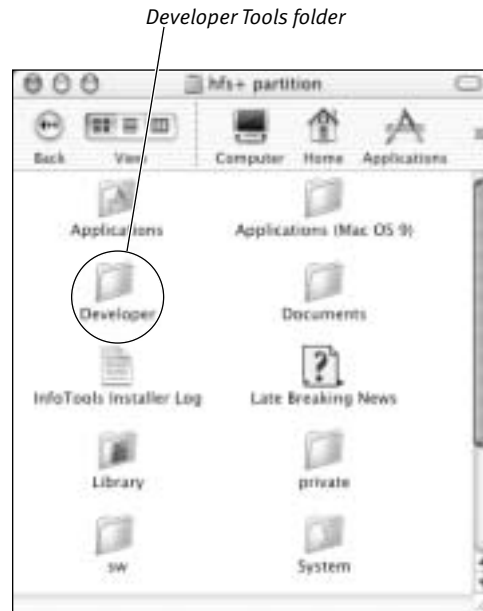


Figure 0.5 A Finder window showing the top level of the system disk. The folder containing the Developer Tools is highlighted.

Requirements

There are a few requirements for effectively using this book. Odds are, you already have all of them covered.

Adventurous and enthusiastic attitude

This is the most important requirement. If you meet this one, you will be able to master the others or do without them. Learning Unix is about learning a richly diverse collection of tools that are part of a lively ecosystem of software development. Unix is an environment for collaborative computing, and by stepping into it, you become part of an ongoing human phenomenon.

OK, enough philosophy. Here are the technical requirements:

Mac OS X 10.2 or later

This book is based on Mac OS X version 10.2 (Jaguar). If you have an earlier version of Mac OS X, then a few things will be different from their descriptions in this book.

Be an administrator

You must be logged in as an “administrative user” for many of the tasks covered in this book, particularly for installing software and conducting system-admin tasks. If you aren’t sure what an administrative user is, go to the Help menu in the Finder and search on “administrative user.”

Have the Developer Tools installed

Several parts of this book require that you have the Mac OS X Developer Tools installed. This is a collection of software included with Mac OS X but not always installed by default.

Depending on which version of Mac OS X you have, the Developer Tools may already be installed. If you have a folder called Developer at the top level of your hard drive, then the Developer Tools are installed.

Figure 0.5 shows a Finder window with the Developer folder highlighted.

The Developer Tools may be on a separate CD that you must install. If you don’t have the CD, there may be an installer application in your Applications folder (in the Installers folder). Also, you can find links to download the Developer Tools from <http://developer.apple.com/tools/> or <http://connect.apple.com>.

Connection to the Internet

Many of the tasks in the book assume that your machine is connected to the Internet, particularly those tasks involving interacting with other machines over networks.
