## IN-TEXT REFERENCES

*To cite sources within the body of your paper, use a parenthetical acknowledgement including an author's name and page number, making sure to stay consistent with the full reference listed in your works cited.*

### Straight Quote from Text:

Creative men and women make "history forgivable by enriching our heritage and our lives" (Durant 406).

### Paraphrasing w/ author's name in text:

Ben Franklin's autobiography states that he prepared a list of thirteen virtues (135-137).

**Citing an entire work:** Kurosawa's Rashoman was one of the first Japanese films to attract a Western audience.

**Works with multiple volumes:** *give the volume number, then pages:* (Lauter et. al. 2: 800-812)

**No author available:** *use title:* (Report 3)

**Corporate authors:** *use common abbreviations:* (Natl. Research Council 15)

**Multiple works by same author:** *use title* (King Lear 27)

**Indirect sources:** *give direct and indirect source:* (Ernest Rockford, qtd. in Boswell 450)

**Classic work with many editions:** *give regular citation plus identifying info, separated by a semi-colon:* (Dostoevsky 1; pt. 1, ch. 1)

**Citing more than one work in one paranthetical reference:** *separate by semi-colon:* (Frank 42; Craner 308-311)

Answer. Save.Â If they are old books you need to consult a book like 'The Oxford Companion to English Literature' and older books are not always dated. If it has one date in then it is generally the only edition at that time. For modern books - nearly every case bound book is a first edition and I have not heard of a publisher affording a second run for hard backed books like this in the last 50 years but in any case modern books are easier to date as it is a legal requirement in UK. First editions are not always valuable. 0. For other uses, see First Edition (disambiguation). This article needs additional citations for verification.Â A "first edition" per se is not a valuable collectible book. A popular work may be published and reprinted over time by many publishers, and in a variety of formats. There will be a first edition of each, which the publisher may cite on the copyright page, such as: "First mass market paperback edition".Â First edition most often refers to the first commercial publication of a work between its own covers, even if it was first printed in a periodical: the complete text of Ernest Hemingwayâ€™s The Old Man and the Sea appeared in the September 1, 1952 issue of Life, yet the generally accepted âœfirstâ€ edition is the hardcover book Scribnerâ€™s published on September. 8, 1952. MLA. Notes: More citation types will be added later, but those that are present are accurate. The works cited list should be double spaced, and the citations should have hanging indents.
