Information about the University Library Special Collections held at the Modern Records Centre, University of Warwick. The private libraries of two Renaissance scholars, Roberto Weiss and Edward Hutton, were acquired in 1969 and now form an important part of the Central Campus Library's holdings in Italian history, literature and art. Edward Hutton, a well known amateur scholar in Italian fine art, history and arts during the inter-war period, had a particular interest in the history of the Franciscans. Professor Weiss was Head of the Department of Italian Studies at the University of London and collected in the area of humanism in Italy. The oldest part of the collection comprises over 500 16th, 17th and 18th Special Collections houses an incredible collection of rare books and historic documents, as well as materials pertaining to the history of Johns Hopkins University. Highlights include the Arthur and Janet Freeman Collection of Literary and Historical Forgery, the Roland Park Company Papers, and over sixteen thousand images in our University Photograph Collection.
